Delegation of Treasurer's Powers and Functions

- (a) under section 39(1) of the *Financial Management Act* and with reference to section 43 of the *Interpretation Act*, revoke the instrument entitled "Delegation of Treasurer's Powers and Functions" dated 2 May 2013; and
- (b) under section 39(1) of the *Financial Management Act* and with reference to section 42(1) of the *Interpretation Act*, delegate my powers and functions under the provision of the *Financial Management Act* specified in the Schedule to each person from time to time holding, acting in or performing the duties of an office or position specified opposite the provision, subject to any condition or limitation specified opposite the provision.

34(2)	Any Accountable Officer	Delegation applies only in relation to signing instrument and not in relation to agreement that instrument may be signed by Minister or some other person. Accountable Officer may sign instrument only in respect of the Accountable Officer's area of responsibility.
35(2)(b)	Minister of Trade, Business and Innovation	Delegation applies only in relation to the disposal of property under the Vehicle Gifts and Long Term Loans Program within the approved annual budget.
